Policy and 2024 Elections: Big Issues, Consequences



Major Win for Trump

- Trump won all battleground states in a red wall while the blue wall (Pa., Wis., Mich.) cratered for Democratic challenger Kamala Harris. Trump: greatest political comeback in U.S. history.
- Trump won other battleground states: N.C., Ga., Nevada & Ariz.
- Trump 312 electoral votes; Harris: 226.
- First candidate in over a century to reclaim White House after losing it, just the second candidate in U.S. history to win nonconsecutive White House terms.
- Republican Party won popular vote for first time since 2004.

Trump's GOP = Major Realignment

- Even stronger support in rural America (63% to 36%)... likely a backlash against the ag policy moves of the Biden/Harris administration.
- Strong support among working-class voters. Trump won 55% of voters without a college degree. That was up from 51% in 2020 in his race against Biden. Harris, meanwhile, struggled to pull together the diverse coalition that elected Biden in 2020, and she was weighed down by negative views of the economy under the Biden administration.
- Massive GOP realignment. Now focuses on working class, younger Americans, including young Black men, and Hispanics... former Democratic strongholds.

Razor Thin GOP Control of House

- GOP: 220* DEM: 215... Now 217-215
 - * Trump tapped 3 current House GOP members for Cabinet
- House GOP replacements not in place until April 2025
- Four Dem states account for 85 of Dem's 215 House members.
 Calif. 43-9 | N.Y. 19-7 | III. 14-3 | Mass. 9-0
- Current House Speaker Mike Johnson (R-La.) should win speaker again in January 2025.

New Star: Elon Musk

- Musk helped Trump and the GOP in campaign funding and messaging.
- Trump tapped Musk & Vivek Ramaswamy to lead effort to make the gov't more efficient (DOGE).
- Musk vowed to keep his political action committee going beyond the presidential election, a sign the world's richest person is building a political machine to support Trump.

The Federal Workforce

Elon Musk wants to spearhead mass layoffs among federal government workers. But most of those agencies are fairly small, while workers are a small share of spending.

2024: Election impacts: Red wave

- BIG impacts as GOP won House, Senate & White House Reason: Generally, one budget reconciliation measure allowed for a FY
- Putting revenue-generating tariffs language as part of reconciliation?

Key: Will have chance to rewrite tax code as Trump tax cuts expire after 2025

Tax Cuts & Jobs Act (TCJA) of 2017

The Tax Cuts and Jobs Act of 2017 made several significant changes to the U.S. tax code, including:

- 1. Lower individual tax rates and adjusted income brackets. Top marginal rate reduced from 39.6% to 37%.
- 2. Nearly doubled standard deduction (e.g. from \$6,500 to \$12,000 for single filers).
- 3. Eliminated personal exemptions.
- 4. Expanded Child Tax Credit from \$1,000 to \$2,000 per child and increased income thresholds for eligibility.
- 5. Capped state and local tax (SALT) deductions at \$10,000.
- 6. Limited mortgage interest deduction to loans up to \$750,000, down from \$1 million.
- **7.** Reduced corporate tax rate from 35% to a flat 21%.
- 8. Created 20% deduction for pass-through business income (some exceptions).
- **9.** Increased estate tax exemption, doubling it to over \$11 million for individuals (inflation escalator).
- Trump's plan would add \$5.8 trillion to the debt over 10 years, according to the Penn Wharton Budget Model.
- Harris' plan would add \$1.2 trillion to the debt over 10 years, the Penn Wharton Budget Model found.

Estate Taxes

Current Federal Estate Tax Provisions:

- 1. Federal estate tax exemption for 2024 is \$13.61 million per individual, \$27.22 million for married couples
- 2. Exemption amount established by the TCJA in 2017, which roughly doubled the previous exemption.
- 3. Top federal estate tax rate currently 40%.
- 4. Exemption is portable, meaning surviving spouse can use deceased spouse's unused exemption amount.

Changes if TCJA Expires:

- 1. TCJA provisions to sunset end of 2025 if Congress does not act to extend them.
- 2. If TCJA expires, estate tax **exemption would revert to pre-2018 levels: approximately \$5-6 million** per person (adjusted for inflation).
- 3. This would effectively cut the current exemption amount in half.
- 4. Reduction in exemption amount could significantly increase estates subject to federal estate tax.
- 5. Top estate tax rate of 40% expected to remain unchanged.







Trump China Policies

- Threatens to impose 60%+ tariffs on Chinese goods...
 Plus 10% tariffs on Day 1 of admin.
- Advocates for revoking China's permanent normal trade relations status



- Supports phasing out imports of essential goods from China
- Aims to stop Chinese purchases of American real estate and industries

Need to control strategic goods and technologies, invest in innovation, re-shore supply chains, and combat Beijing's unfair trade practices.

Trump victory, alongside GOP gains in Congress, will fuel push to limit tax incentives for EV sales and new ventures to capture carbon dioxide, generate renewable power and manufacture clean energy technology.

Trump will have wide latitude to rewrite Dept. of Treasury rules governing tax credit qualifications.

Winners:


Oil and gas interests will thrive as Trump vows to remove barriers to production and offer more federal land for drilling.



Farm Income Forecasts Don't Tell Whole Story




Net Cash Income: Big Differences

Percent Change in Inflation Adjusted Net Cash Farm Income by Commodity, 2023 to 2024.



Trump Impact: Winners

Winners:

- **Production ag**, larger farmers with far less emphasis on equity issues.
- Farmers favoring deregulation, which is beneficial for increasing production and reducing operational costs.



Trump Impact: Losers

Losers:

- Small and diversified farms, socially disadvantaged.
- Trump's trade policies, especially tariffs, will lead to retaliatory measures from other countries, impacting U.S. farmers dependent on exports.
